This Privacy Policy details the privacy practices of An Tairseach Organic Farm & Ecology Centre, as it pertains to **information that we collect through websites operated by us** from which you are accessing this Privacy Policy, including our social media pages, and email messages, as well as any other communications with us. By willingly providing personal and other information to us, you are consenting to the terms and conditions of this Privacy Policy.

An Tairseach Organic Farm & Ecology Centre has the utmost respect for the privacy of all our customers and understands the importance of privacy to you. To this end, and in accordance with current privacy legislation, we will only use your personal information in accordance with this Privacy Policy. We encourage you to read this policy, to understand what types of information we collect, and how we use or disclose it.

An Tairseach Organic Farm & Ecology Centre will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with GDPR and any other relevant data protection legislation.

Personal Information We Collect

An Tairseach Organic Farm & Ecology Centre collects only the personal information we require to effectively respond to your requests for our customised products and services and to enable you to use the resources available on our website. This personal information includes, but is not limited to, your name, company name, physical address, email address, phone number(s) and any other information that itself can identify or, when tied to the above information, may identify you as a specific individual.

Email Marketing - Device Information We Collect

When you visit our website, you can sign up for our email marketing newsletter. This is done via an opt-in email system where you specifically give us permission to send you email marketing newsletters with info on what's happening at An Tairseach Organic Farm & Ecology Centre. To provide you with the appropriate level of service, we may also collect information about your computer, including your IP address, operating system and browser type for system administration purposes. When you open an email newsletter we have sent to you, our software gives us details such as the number of times you have read the email and the links you have clicked. Tracking is only used on marketing emails (e-news, e-zines, newsletters) and not in conjunction with any other type of email communications with An Tairseach Organic Farm & Ecology Centre staff. You have the right to unsubscribe from our emails at any time, by phoning, emailing, visiting our website to update your preferences or clicking 'unsubscribe' at the footer of one of our marketing emails.

How We Use & Share Your Personal Information

An Tairseach Organic Farm & Ecology Centre is the sole owner of any information collected on this site. We will not, under any circumstances, sell, share, or rent this information to any other organisation in any way other than what has been detailed in this Privacy Policy.

If a user contacts An Tairseach Organic Farm & Ecology Centre with a general enquiry, we may require you to provide An Tairseach Organic Farm & Ecology Centre with personal information such as your contact details so that we can appropriately address your needs. We use other information we hold about you for the following general purposes: to supply you with the products and services you request; to give you booking confirmations and updates; to manage your account, including issuing invoices and providing booking notifications; to communicate with you; to respond to any questions and comments; to follow up on our customer service, if necessary; to gain feedback on our products, services, and website; to tackle disputes, collect payments due, or resolve outstanding issues; to prevent potentially prohibited or illegal activities.

If you enter into correspondence with us regarding a booking, enquiry or complaint, we may also keep records of that correspondence.

In addition to the circumstances described above, we may disclose your information if required to do so by law, court order, as requested by other government or law enforcement authorities, or in the good faith belief that disclosure is otherwise necessary or advisable, including (without limitation) when we have reason to believe that disclosing the information is necessary to identify, contact or bring legal action against someone who may be causing interference with our rights or properties, whether intentionally or otherwise, or when anyone else could be harmed by such activities.

Emails

We always have our customers' needs at the forefront of our approach. We want to make it as simple as possible for you to enjoy the facilities and activities at An Tairseach Organic Farm & Ecology Centre. One way we do this is by emailing you with information we believe will be of interest to you about specific opportunities we have available. For example, if you have tried to make a booking with us, we may send you a follow up email or try to contact you by other means.

Social Media Services

Cookies

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive. We use cookies in several ways. Cookies are also used to determine whether you have visited our website before, and track the effectiveness of our advertising and marketing by monitoring whether you came to our website from a particular Internet address or advertisement.
